These deposits should be a separate check, received with the FINAL PAYMENT. This will be completely refunded upon the return of your cake supplies the following **Monday** after the wedding. The value of any broken or missing pieces will be deducted from your deposit. Because our equipment usually cost more than your deposit, you may be required to pay the difference. Delivery Schedule: We will review with you 2 weeks before the wedding the time you would like the cake delivered. Please make sure you have cleared your delivery time with the hall, so the area where the cake should be delivered is ready to go.

If you decide to pick up your wedding cake: If you choose to pick up your wedding cake you should make sure that you have a clean, flat surface to set cake on while driving. Vans, Sport utility and any vehicle that the back seat folds in so the air can make it to the trunk are the best for traveling with the cake. The cakes are not boxed and you should never have any one hold any part of the cake on their lap. Speed is never the issues it's stopping and turning corners. No slamming on the brakes and taking corners fast. Once the cake is picked up we are not responsible for any damage.
